
## Recycling capability:

Due to the great variation between models we have chosen the representative model 31420, PantoSwing-VF, height 46 cm, for the purposes of analysis. The packaging is not considered here because, as far as possible, we do without this. Reusable packing blankets made from 100% recycled materials are used to provide protection during transport.



### Conformity:

VS's products comply with the REACH regulation and are also RoHS-compliant: they do not contain any materials from Annex XIV (1907/2006/EC) or the SVHC candidate list exceeding the limit value of 1000 ppm. Electrical components have been registered by VS under WEEE reg. no. DE 45470288 or by our suppliers in accordance with the German law on electrical and electronic equipment.

## Contribution to building certifications:

VS products can help achieve desired building certification in accordance with LEED, WELL, etc. Depending on the selected products, points can be acquired relating to criteria in the fields of recycling/waste elimination or non-toxic constituents/low emissions.
